1. Transversal Evolutionary Framework

- 1.1. **Initial Problematic** In exploring the innate spiritual capabilityy of Homo sapiens [1], I realized that ancestral species of the Homo genus, such as Homo erectus or Homo heidelbergensis, seem to lack such a capability. 4. Towards an Integration of the Transcendent in the Exploration of Natural Laws

The holisophic approach opens new perspectives for exploring the transcendent realm by leveraging deductive and abductive reasoning applied to natural laws. This methodology should enable the tackling of fundamental problems such as:

- (1) The definition and characterization of the transcendent realm.
- (2) The nature and fundamental properties of natural laws.
- (3) The identification of natural laws governing both the transcendent and natural realms.
- (4) The exploration of transcendent sources of information accessible from the natural world.
- (5) The philosophical and scientific implications of the organic and physiological origin of all human knowledge, based on the observation that organic cells and the constitutive organs of living beings, skillfully organized by the mystery of life, are not only the origin of the emergence of *Homo sapiens* but also represent the fundamental building blocks at the source of all human knowledge.

Part 3. Conclusion

The holisophic approach constitutes a novel pathway for comprehensively addressing complex issues where the material and transcendent realms intersect. By merging science, philosophy, and theology, it initiates a quest for boundless truth, liberating our thought from the restrictive frameworks imposed by materialistic and reductionist approaches.
